DSC P2 16.8mm Kits

DSC P2 Kits have been KIT09002 compatible since October 2001. To achieve compatibility, a Heatshield Cover (AQ002D01) was added.

If you wish to upgrade an existing DSC P2 16.8mm kit to KIT09002 compatibility, you will need to purchase an upgrade kit (KIT237AA), containing a Heatshield Cover (AQ002D01). UJCM021 contains the new procedure.

KIT22120 Serial Nos 001 – 064 and

KIT22130 Serial Nos 001 – 023

are KIT09001 compatible only and will need upgrading for KIT09002 use. No KIT22110 kits have been sold.

Please note that a Supplement Common Kit (KIT09103) is also required for KIT09002 use.

UQJ Common Kit

The UQJ Common Kit (KIT30000) is to be superseded by KIT30001.

The reason for the change is to ease assembly for high fibre count cables by substituting Melinex Retaining Loops (BB080S01) for the Fibre Retaining Pads (BB028D01).

UQJCM 3_2 contains the procedure for using the Melinex Retaining Loops and will be issued in the December 2004 Explorer. The procedure for using Fibre Retaining Pads is retained in UQJCM 3_2 for existing KIT30000 kit-holders.

If you wish to upgrade a KIT30000 to KIT30001, you will need to purchase an upgrade kit (KIT238AA), containing Melinex Retaining Loops (BB080S01).
