KCS OS-H2 & OCC SC-100 Hydrogen Managed End Specific Kits

Following on from UJC Bulletin 033, the UJC would like to announce a further change to KCS OS-H2 & OCC SC-100 Hydrogen Managed End Specific Kits as OCC SC-100 is confirmed as identical to KCS OS cables. For this reason, KCS OS-H2 and OCC SC-100 hydrogen managed (Adhesive Technique) end specific kits have been rationalised and will be called KCS OS-H2 and OCC SC-100 (H2 Adhesive) End Specific Kits. The table below gives details of the changes.

UJCM064 will be discontinued and the cable end preparation techniques will be detailed in UJCM 026/3, which will be for KCS OS-H2, OS-TUBE & OCC SC-100 cables.

Adhesive Kits: Kits 15070 and 15110 will be discontinued and the new adhesive kit for KCS OS-H2 (H2 Adhesive) and OCC SC-100 (H2 Adhesive) will be KIT15071.

H2 Soldering Technique: KIT15072 will be introduced for those customers that still have hydrogen managed kits using the soldering technique. This kit will be available until April 1st 2009 to allow time for customers to upgrade their end specific kits for the adhesive method.
