Armour Protection Kit Clarification for Double armoured Cables

The UJC would like to provide further clarification on the armour protection kits required for double armoured cables.

Some of the newer Double Armoured cables have smaller outside diameters than the earlier types and hence use Single Armour buffers, instead of Double Armour (DA) Buffers, which are not included in the End Specific Kit (ESK). This Bulletin supplements UJC Bulletin 027 and clarifies which Protection Kits are required for each Double Armoured cable.

Double Armoured cables that use Double Armoured buffers: The buffers are located in the End Specific Kits. Only Armour Protection Kit KIT10060 is required.

Double Armoured cables that use Single Armoured buffers (except Ericsson GJMLTV): The buffers are located in KIT10070, so both KIT10060 and KIT10070 are required.

Ericsson GJMLTV Double Armoured cables: The single Armour buffers are located in the End Specific Kits. Only Armour Protection Kit KIT10060 is required.
